- The affiliate, in its full legal and entrepreneurial autonomy, is willing to join the network **Flos Olei Points** with adequate organization and to fulfil all obligations stated by the present document in order to guarantee the correct use of the supplied material in the common interest of both parties.

5. Drawing up the present document, the affiliate commits itself to buy from the company **E.V.O. srl** at least 10 (ten) copies of the publication **Flos Olei - a guide to the world of extra virgin olive oil** with a 40% discount on the published price, with the addition of shipping expenses (see the shop www.flosolei.com/shop).
